



## **RULES & REGULATIONS**

Only 154,000 tickets will be printed.

### **GENERAL RULES**

Only ONE method of payment will be accepted.

Only ONE mailing address will be recorded.

Foothills Hospital Home Lottery tickets, 50/50 Add-On tickets and 100 Days of Winning Cash Calendar Add-On tickets will be mailed separately.

Persons must be 18 years of age to purchase a ticket and the name of a person under 18 years of age may not be written on the ticket.

Only tickets that have been paid for, and verified as paid for, are eligible for the respective draw(s). All inquiries regarding the chances of winning and method of awarding prizes can be made to the licensee by phoning toll free at 1-833-208-4388.

The following, including their spouse and any related or dependent person residing in the same household, are prohibited from purchasing a ticket: Calgary Health Trust employees, Board members and Development Council members, the raffle manager and their employees, and the partners and employees of the professional services firm of MNP LLP.

Tickets may only be sold and purchased within Alberta. Restrictions apply. If your ticket contains an error, please call toll free at 1-833-208-4388.

All ticket purchases are final, and refunds are not available. 4,005 prizes will be awarded. All prizes awarded are new product. Prizes awarded may not be exactly as illustrated.

◆ Each Foothills Hospital Home Lottery ticket in a 3-pack, 5-pack or 10-pack, each 50/50 Add-On ticket in a 5-pack or 15-pack, each 100 Days of Winning Cash Calendar Add-On ticket in a 3-pack or 6-pack, and each Mega Pack and Max Pack tickets must contain the same name and contact information. Prizes must be accepted as awarded.

## **DRAW ORDER**

The first draw will be for the VIP Prize, the second draw will be for the Bonus Prize, and the third draw will be for the Early Bird Prize. Thereafter, draws are made in order of ascending retail value. After each draw, the winner's name and ticket number are recorded and the ticket number remains eligible for all subsequent draws.

Each ticket purchased before the VIP deadline will be eligible for all 4,005 draws. Tickets purchased after the VIP deadline but before the Bonus deadline will be eligible for 4,004 draws. Tickets purchased after the Bonus deadline but before the Early Bird deadline will be eligible for 4,003 draws. Tickets purchased after the Early Bird deadline will be eligible for the remaining 4,002 draws.

Official tickets and prize notification letters are addressed to the primary ticket holder only and mailed to the address provided by the ticket purchaser.

In the event that a winning ticket is held in more than one name, it is the responsibility of the primary ticket holder to share winning information with those parties.

### **UNCLAIMED PRIZES**
